WHEREAS, New York State Real Property Tax Law § 467 authorizes the Town, following a public hearing, to adopt a local law, ordinance, or resolution, providing that real property owned by one or more persons, each of whom is sixty-five years of age or over, or real property owned by husband and wife or by siblings, one of whom is sixty-five years of age or over, or real property owned by one or more persons, some of whom qualify under this section and the others of whom qualify under Real Property Tax Law § 459-c, shall be exempt from taxation by any municipal corporation in which located to the extent of fifty per centum of the assessed valuation thereof (the "Senior Citizens Exemption"); and

WHEREAS, Real Property Tax Law § 467 further provides that the Town Board may amend any local law, ordinance, or resolution setting forth the Senior Citizens Exemption so as to increase the maximum income eligibility level to the extent provided in the schedule set forth therein; and

WHEREAS, Macedon Town Code § 260-3 codifies Local Law 2-1996, whereby the Town Board adopted the Senior Citizens Exemption as prescribed in Real Property Tax Law § 467 and authorized the Town Board to adopt resolutions setting forth the terms and conditions of the exemption, including eligible income levels, as prescribed by statute; and

WHEREAS, on January 12, 2023, the Town Board held a public hearing to receive public comment on a proposed income eligibility schedule for the application of the Senior Citizen Exemption; and

WHEREAS, the proposed income eligibility schedule is consistent with the schedule authorized by Real Property Tax Law § 467; and now therefore,

BE IT RESOLVED, the Town Board hereby adopts the following income eligibility schedule for the application of the Senior Citizen Exemption pursuant to Real Property Tax Law § 467:

WHEREAS, on December 9, 2022, the Governor signed into law Senate Bill 9131, amending New York State Real Property Tax Law § 466-a to authorize the governing body of any city, village, town, school district, fire district or county, following a public hearing, to adopt a local law, ordinance, or resolution, providing that real property owned by an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service or such enrolled member and spouse residing in any county shall be exempt from taxation to the extent of up to ten percent of the assessed value of such property for city, village, town, part town, special district, school district, fire district or county purposes, exclusive of special assessments; and now therefore,

BE IT RESOLVED, the Town Board hereby adopts the following the Volunteer Firefighters / Ambulance Workers Exemption permitted by Real Property Tax Law §466-a; and

BE IT FURTHER RESOLVED, such exemption shall not be granted to an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service residing in the Town unless:

- (a) the applicant resides in the Town which is served by such incorporated volunteer fire company or fire department or incorporated voluntary ambulance service;
- (b) the property is the primary residence of the applicant;
- (c) the property is used exclusively for residential purposes; provided however, that in the event any portion of such property is not used exclusively for the applicant's residence but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption provided by this section; and
- (d) the applicant has been certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department, or voluntary ambulance service as an enrolled member of such incorporated volunteer fire company, fire department, or voluntary ambulance service, as determined by the Town Board; provided, however, that such each applicant have a minimum two years of service prior to the time of application.

BE IT FURTHER RESOLVED, any enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service who accrues more than twenty years of active service and is so certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service, shall be granted the exemption for the remainder of his or her life as long as his or her primary residence is located within the Town; and

BE IT FURTHER RESOLVED, application for such exemption shall be filed with the Town Assessor on or before the taxable status date on a form as prescribed by the Commissioner of Taxation; and
