# RESOLUTION NO. 97 (2023) CDBG CARES 2ND PUBLIC HEARING

The intention of this program was to support Food and Beverage small businesses in the Town of Macedon to recover from the Covid-19 Pandemic and build resiliency to the impacts of a potential future outbreak.

The town completed an RFP process for a grants consultant to direct the program and assist businesses with applying for funding. LaBella Associates was selected based on qualifications and has since directed the program in collaboration with Town leadership and staff.

The Town assembled a selection committee consisting of the Town Engineer, A local bank representative, and a local business owner. This committee has collected, reviewed, and designated funds to businesses based on qualification to the program, need, and compliance with grant requirements. All of this was done in collaboration with LaBella Associates to ensure grant compliance.

Although the committee is still awaiting final approval from the State and Federal review for some businesses, the following businesses have been either awarded or funds designated from the program.

Franks Pizza Shack (Salvatores) - \$66,250
The Log Cabin Restaurant - \$50,000
Twisted Rail Brewery - \$50,000
Disbatch Brewery - \$50,000
Yellow Mills Diner - \$43,500
The Purple Painted Lady - \$50,000
Eli's Mexican Restaurant - \$66,250
West Wayne Restaurant - \$24,000
Macedon Hills Family Restaurant - \$50,000

These businesses all completed their applications with all necessary attachments prior to the deadline of March 30<sup>th,</sup> 2023 The two businesses funded more than the original maximum of \$50,000 were selected based on a scoring matrix including grant compliance, need, and microenterprise status.

The Town has discovered additional need after completing a financial analysis on all participating businesses and interest from other businesses to increase their resiliency to a potential future covid outbreak.

The Town is taking every step possible to secure additional funds and or resources for these businesses.
