RESOLUTION NO. 145 (2023) NORTH EASTERN RESCUE VEHICLES, INC

RESOLVED the Town Board authorizes the Supervisor to sign the Contract with North Eastern Rescue Vehicles, Inc. dated 1/18/2023 Proposal for (1) 2023 Crestline Type III CCL Module built on a Chevrolet G3500 Chassis Ambulance at a total cost of \$155,500.00 and be it further

RESOLUTION NO. 146 (2023) AMERICAN RESCUE PLAN ACT (ARPA) ALLOCATION

WHEREAS, on March 11, 2021 the President of the United States signed into law the American Rescue Plan Act (ARPA) to provide continued relief from the impact of the COVID-19 pandemic; and

WHEREAS, the ARPA program appropriates funds to assist state, local, tribal and territory governments in responding to the COVID-19 pandemic; and

WHEREAS, the Town of Macedon has been notified of ARPA funding in the amount of \$ <u>911,484.44</u>, paid to the Town of Macedon on 10/8/2021 \$ 453,889.10, 7/20/2022 \$ 455,742.21 And a check in the amount of \$ 1,853.13 for unclaimed ARPA \$ from other Counties, Towns, and Villages

WHEREAS, the Coronavirus State and Local Fiscal Recovery Funds provide needed fiscal relief for recipients that have experienced revenue loss due to the onset of the COVID-19 public health emergency; and

WHEREAS, Treasury presumes that up to \$10 million in revenue has been lost due to the public health emergency and recipients are permitted to use that amount (not to exceed the award amount) to fund "government services."; and

WHEREAS, Recipients may elect a "standard allowance" of \$10 million to spend on government services through the period of performance; and

WHEREAS, All recipients may elect to use this standard allowance instead of calculating lost revenue using the formula provided by the US Treasury, including those with total allocations of \$10 million or less; and

WHEREAS, the Town of Macedon has the need to fund government services while in the recovery phase of the COVID-19 pandemic and

NOW, THEREFORE IT BE RESOLVED, the Macedon Town Board authorizes the following obligations of its ARPA

\$:

<u>Section 1.</u> The following allocation of ARPA funding to fund government services under the replacing lost public sector revenue spending category as follows:

Project A Improvements & Upgrades, emphasizing the need for Handicap Accessibility and Playground Equipment to all Town-owned Parks including but not limited to Gravino Park, Bullis Park, Bickford Park, and the Veteran's Memorial Gazebo located by land owned by the NYS Canal Corp. Authority located at 1 Canal Park

AND BE IT FURTHER RESOLVED,

This amended ARPA Project is a direct result of the recent findings by the NYS Canal Corp. that the Town's plans for installing a complete culvert replacement of the Railroad Avenue Culvert Project by the Macedon Highway Department has been deemed "undoable" per the NYS Canal Corp. as an Independent Engineering Study done by the NYS Canal Corp. reported the damage and erosion to this spillway area now require a complete bridge replacement with an estimated cost of \$ 2,500,000.00, far more than what the Town of Macedon can afford AND the fact the land is currently in the NYS Canal Corp. name.

Original ARPA \$ Obligation Plan

Project A	Railroad Avenue Complete Culvert Replacement estimated between \$ 650,000.00 - \$ 750,000.00
Project B	Remaining \$ Estimated between \$ 161,484.44 - \$ 261,484.44 to be used to do Upgrades and Improvements to Gravino Park and Bullis Park, with a focus on Handicap Accessibility and Update Playground Equipment.
