The public hearing resumes for the Partial Tax Exemption – if there are any questions from the Board or the residents you can ask them now.

Councilman Maul asked if the third option, being able to deduct non-covered medical expenses, would be a nice benefit for the Seniors but the management of that activity would be a nightmare. Is there any provision for us on that option alone? Is there any provision for us to create a schedule of medical and drug expenses and deduct that much, or does it need to be documented or you cannot have it? The Assessor stated that it would have to be documented and you need to understand what is covered by an outside insurance company. You can look at the co-pay but then are unable to know if it is covered somewhere else. It is her understanding from other Towns that people come in with shoe boxes full of medical receipts and prescriptions that it is too hard to manage. Councilman Maul stated that he could see where it would be hard to keep track of that especially not knowing where insurance A did not cover it but do you have any other insurance that we do not know about?

A resident asked what about people who have a substantial amount of medical that they can itemize on their taxes would that amount condense down all their expenses? The Assessor asked if that is a spot on the tax return. The resident stated that having up to 10% on the tax return after that would be an exception on their taxes. There are people who document that they are in nursing homes and it is easily where they could document up to \$120,000 for the whole year and in that case, it is way beyond what you would have to look at. The Assessor stated that if it is on their tax return and it is subtracted out of FAGI it would already be included in this exemption. It is more for people who do not file tax returns. It would be hard to get that information. Councilman Maul stated probably would have to be equally available to everyone so if we say that you must produce a tax return and if they do not fill out a tax return then it would be discriminated against. The Assessor said that most of the senior residents receiving this exemption do not fill out a tax return.

Councilman Maul stated that he wanted to go back to the other two options. So, in option 1, the FAGI is a new element of the calculation that was not considered before? The Assessor stated that it was not. This option is to opt in not to subtract out the IRA distribution from FAGI.

FAGI stands for Federal Adjusted Gross Income

Councilman McEwen asked if the Assessor knew how many people would qualify if this stayed in place. The Assessor says that she turns away 15-20 people a year because their interest and dividends put them over the limit.

Councilman Maul says that if we opt to do nothing it would be column two. So, we will not know how many will qualify until they come to ask.

A resident stated that only applies to social security so if a person is only making \$25,000 in social security they would be taxable on this so it would be better for a person who does not have an IRA.

What other resources are there for people to learn more about this and to learn the range of all the scenarios? The assessor has a chart in the office but will try to come up with something to help better understand. The law went into effect in April. If the Board does nothing this year it will affect next year's tax roll of 2024.

#### PARTIAL TAX EXEMPTION FOR REAL PROPERTY OF SENIOR CITIZENS

WHEREAS, New York State Real Property Tax Law § 467 authorizes the Town, following a public hearing, to adopt a local law, ordinance, or resolution, providing that real property owned by one or more persons, each of whom is sixty-five years of age or over, or real property owned by husband and wife or by siblings, one of whom is sixty-five years of age or over, or real property owned by one or more persons, some of whom qualify under this section and the others of whom qualify under Real Property Tax Law § 459-c, shall be exempt from taxation by any municipal corporation in which located to the extent of fifty per centum of the assessed valuation thereof (the "Senior Citizens Exemption"); and

WHEREAS, Real Property Tax Law § 467 further provides that the Town Board may amend any local law, ordinance, or resolution setting forth the Senior Citizens Exemption so as to increase the maximum income eligibility level to the extent provided in the schedule set forth therein; and

WHEREAS, Macedon Town Code § 260-3 codifies Local Law 2-1996, whereby the Town Board adopted the Senior Citizens Exemption as prescribed in Real Property Tax Law § 467 and authorized the Town Board to adopt resolutions setting forth the terms and conditions of the exemption, including eligible income levels, as prescribed by statute; and

WHEREAS, following a public hearing on January 12, 2023, the Town Board adopted Resolution No. 36 (2023), setting forth the income eligibility schedule for the exemption, consistent with the schedule authorized by the latest amendments to Real Property Tax Law § 467; and

WHEREAS, Real Property Tax Law § 467 further provides that the Town Board may direct that distributions from retirement accounts and annuities are to be included as "income" as defined therein; and now, therefore

BE IT RESOLVED, the Town Board hereby directs that distributions received from an individual retirement account or individual retirement annuity that were included in the applicant's federal adjusted gross income shall be considered income by the Town Assessor when addressing an application for the Senior Citizens Exemption; and

BE IT FURTHER RESOLVED, this resolution shall be effective immediately.
