A local law to override the tax levy limit established in General Municipal Law 3-c

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Macedon, County of Wayne pursuant to General Municipal Law § 3-c, and to allow the Town of Macedon, County of Wayne to adopt a town budget for (a) town purposes (b) fire protection districts and (c) any other special or improvement district governed by the town board for the fiscal year 2026 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Macedon, County of Wayne is hereby authorized to adopt a budget for the fiscal year 2026 that requires a real property tax levy in excess of the limit specified in General Municipal Law, §3-c.

Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.

Except as otherwise provided herein or in the provisions of the WCWSA Sewer Use Rules adopted and incorporated by reference herein, the Town shall apportion the costs for operation and maintenance of the POTW that service the Hamlet of Macedon Sewer District, Macedon Consolidated Sewer District No. 1, and Gananda Sewer District No. 1, and any indebtedness associated therewith, including any obligations incurred by contract with the WCWSA, Town of Marion, Town of Walworth, and Village of Palmyra, by equivalent dwelling units, which shall be assigned to sewer users under the following criteria:

WHEREAS, the Town Board of the Town of Macedon adopted a resolution on the application of Waste Management of New York, LLC dated June 26, 2025 for renewal of its special use permit for the existing Landfill located High Acres Landfill in the Town of Macedon which project operates Monday through Friday, 6:00 am to 4:30 pm; Saturday, 6:00 am to 2:00 pm; and Saturday following a major holiday, 6:00 am to 4:30 pm. and

WHEREAS, the application submitted showed that while the proposed application involved a permit renewal where there will be no material change in permit conditions or the scope of permitted activities, the Board was aware that, subsequent to the granting of its then current special use permit, the applicant had received a special use permit to construct an 8,000 SCFM (standard cubic feet per minute) Renewable Natural Gas (RNG) Facility adjacent to the High Acres Landfill & Recycling Center, and

WHEREAS, by reason of the aforesaid, the Town Board made preliminary SEQRA findings that the proposed renewal was subject to the New York State Environmental Quality Review Act and protectively gave the project a preliminary classification of Type I to allow the Town Board to further review the matter, and

WHEREAS, the Town Board has completed its preliminary review and makes the following findings:

High Acres, which is owned and operated by Waste Management of New York, LLC (WM), has been in operation since 1972. Since 2007, WM has operated High Acres pursuant to a Special Use Permit issued by the Town of Macedon. The Special Use Permit has a five-year term.

The Town of Macedon issued the current Special Use Permit for High Acres in 2022. WM recently applied to renew High Acres' Special Use Permit (a copy of that application is enclosed). As noted on page 2 of the application, since the current Special Use Permit was issued in 2022, the Town of Macedon approved WM's construction of a Renewable Natural Gas facility (RNG Facility) at High Acres following a separate review of the RNG Facility under the New York

State Environmental Quality Review Act (SEQRA). Besides construction and operation of the RNG Facility, WM's application to renew High Acres' Special Use Permit does not propose any operational changes - e.g., High Acres' permitted acceptance rate, site operating conditions, origin and type of materials managed, and hours of operation will all remain the same.

Renewal of a Special Use Permit "where there will be no material change in permit conditions or the scope of permitted activities" is a Type II action under SEQRA (6 NYCRR § 617.5[c][32]). An activity that has already been subject to environmental review under SEQRA is not a "material change" in "the scope of permitted activities" - and permitting entities are thus "not required to reconsider the environmental impacts of those activities" (Stephentown Concerned Citizens v Herrick, 280 AD2d 801, 804 [3d Dept 2001]).

Consequently, because WM is not proposing any material changes in the environmental conditions in the Special Use Permit or scope of permitted activities at High Acres, and the RNG Facility has already been subject to a separate SEQRA Review, the Town of Macedon has concluded renewal of the Special Use Permit is a Type II action under SEQRA (see Stephentown Concerns Citizens, 280 AD2d at 804; 6 NYCRR § 617.6[a][1]). Since renewal of High Acres' Special Use Permit is a Type II action, no coordinated review is necessary (6 NYCRR § 617.6[b][3]). However, because NYSDEC has previously been identified as an involved or interested agency with respect to actions at High Acres, the Town of Macedon provides the information in this letter as a courtesy.
